
Because of the generosity of our donors, St. Mary School has been able to support a number of needs indicated at the start of the 2009–2010 Annual Fund Appeal. These needs include:


St. Mary School **REVENUE**

• The H.O.T. Program Higher Order Thinking Program was also introduced this year. The H.O.T. Program ensures that St. Mary School fully challenges and encourages the achievement of all its students. It serves students, from kindergarten to grade 8, who demonstrate the ability for advanced work in various curriculum areas.

In its first year, 39 students participated in the H.O.T. Program.

Technology

St. Mary School implemented a Jennings Technology networking and rewiring project for our school computers. St. Mary's was able to install a new back up school computer server with disaster recovery programs. The cost of this project was \$31,359.70.

• New Science Lab Resources
Our Science Lab received new tables this year. The use of the science lab encourages hands—on problem solving skills and exploration for our students. This is an opportunity that prepares our students for ongoing success in high school science programs.


The cost of the tables was \$3,046,00.

Facility Improvements

St. Mary School replaced carpeting in classrooms and hallways as well as three cafeteria tables. Two classrooms received new desks and chairs. A new student water cooler filtration system was put in place along with a new drainage system to prevent classroom water leaks. These physical improvements are a way for us to offer an atmosphere that promotes learning.

The cost of these improvements total \$42,163.91



St. Mary School Achievements 2009-2010

St. Mary School Celebrates its 60th Anniversary



St. Mary School held a 60th Anniversary Mass and Communion Breakfast in October. Close to 150 people came out to celebrate this great milestone including, alumni,

past and present clergy, families and faculty, and parishioners. Senator Fred Madden also attended and read a resolution honoring our 60th anniversary.

Class of 2010

St. Mary School graduated 59 students in June. These students will attend a variety of high schools in September of 2010. These high schools include: Paul VI, St. Joseph's, Bishop Eustace, St. Augustine Prep, Our Lady of Mercy Academy, Gloucester County Institute of Technology, Camden County Institute of Technology, Williamstown High School, Washington Township High School and Shawnee High School.

- Robert Mason was awarded the \$24,000 Byerley Foundation Scholarship for Paul VI High School. Robert will receive \$6,000 per year.
- ◆ Adwoa Nantwi received a \$1,000 scholarship to St. Joseph's High School in Hammonton.
- Tyler Diorio was selected the recipient of the Paul VI High School's Montini Scholarship.

- Alex Bruce won the Knights of Columbus state—wide spelling bee.
- Eleven members of the Class of 2010 marked a special milestone during this year's commencement celebration. These students were members of the first St. Mary Preschool class when it opened in September 2000.

Academics

- For the St. Mary School Middle States reaccreditation project, we began the system "Strengthening Our Academic Community Through a School Wide House System." In this system, each grade from Pre–K through grade eight, selected a patron saint that would become the House Patron. These House Saints will move up with each class. Students are able to earn points for individual accomplishments or for the entire house. This project helps foster a spirit of pride in our school, academics, in self and respect of others in our students. In addition, the individual houses in specific areas that are inspired by the virtues and qualities of the house patron, will promote their area of service.
 - St. Mary School had a composite score of 87% in the IOWA Test of Basic Skills. This means that St. Mary School scored better than 87% of the other schools taking the same test at the same time. The IOWA test is given each year to students in grades 3 to 8. It is a nationally standardized test used

throughout the country to measure the achievement of individual students and our school.

- St. Mary School was awarded the Nonpublic Program School Award by Gloucester County Special Services School District (GCSSSD). The school was honored because of our outstanding commitment to education and supportive approach that has fostered students' successes. Principal Judith McBride, vice principal Claire Whittaker, and school staff were honored at a celebration at Gloucester County Institute of Technology.
- St. Mary student Molly Gilkin, 9, was awarded the Nonnpublic Speech— Language Program Award given by Gloucester County Special Services School District (GCSSSD).

Athletics



- The varsity girls volleyball team won the South Jersey Catholic Girls Volleyball League Championship for the third year in a row.
- The varsity boys baseball team won the BGSS Baseball Conference Championship against Our Lady of Hope with a score 6-2. St. Mary's finished the season with a 12-2 record.
- The varsity cheerleading team won back to back years and are now the reigning GCCAL Champions.
- The JV cheerleading team had an undefeated competition season and won first place in the GCCAL JV Division.
- Thirty—five varsity and junior varsity cheerleaders were invited to be VIP guest audience members at Good Morning America. They performed cheers during commercial breaks and had the opportunity to meet the hosts and guests following the show.
- Track members Sydney Gans, Gabby McGlynn, Kelly Guglielmo and Jill Farrell took first place in the 4 X 100 at the Track Meet of Champions.
- The senior girls track members were in the Penn Relays in April and came in 6th place at 59 seconds.

• The chess club participated in the Ambassador Christian Annual Chess Tournament. Our club members in the different age categories achieved many first, second and third place medals.

• St. Mary School "actors" and members of the stage crew performed Willy Wonka Jr. This is the fifth musical the Performing Arts Club has presented since it began in 2006.



Community

- Our students reached out to help and thank others in local, national, and international communities. During the school year, St. Mary School students collected items such as baby products that were sent to Haiti as well as a local women's shelter, animal items for the Gloucester County Animal Shelter, and candy for soldiers oversees. They also wrote thank you cards for those who helped clean our church and wrote letters to soldiers. This community service was part of St. Mary School Saint House System and our World Crusaders Club.
- All the students from kindergarten through eighth grade marked International Day of Peace on September 21st by making Pinwheels for Peace. The students placed hundreds of handmade pinwheels expressing their thoughts in words and drawings about peace around the school buildings. Their efforts were also recognized with photos in the Catholic Star Herald, The Philadelphia Inquirer, and the Gloucester County Times.
