Aftercare Program Handbook 2026-2027



Welcome to St. Mary School Aftercare Program. We are committed to providing a loving Christian, safe, positive, and structured environment for all students from Preschool (must be fully potty trained and self-sufficient in the bathroom) through 8th grade. St. Mary School Aftercare Program will be held in **Marian Hall** for the 2026-2027 school year.

Participation in the St. Mary School Aftercare Program is a privilege. Due to the high demand of students who need to attend aftercare, we are requesting that students with working parents ONLY attend the program. This is not a program intended for babysitting, play dates, and students who want to be with their friends.

Below are a few things you should know about the program.

1. The Aftercare Program will be in session every day until 5:30 p.m. A snack will be provided each day.
2. If your child will not be attending the program on a scheduled day, please send a note to the school addressed to “Aftercare Program” along with a note to the teacher. **Without a note the child will remain in Aftercare.**
3. We accept children from Preschool through 8th grade. The program includes activities such as indoor play periods. All students must be able to conduct themselves safely and appropriately in a group setting. The extended length of a school day may be difficult for some children. If adjustment to this extended day is not in the best interest of all the children, your child may be asked to leave the program. With the love of Jesus and His Mother Mary, we will work together to make this program an enjoyable and fun-filled experience for your child.
4. **THERE WILL BE NO AFTERCARE ON ANY SCHOOL EMERGENCY CLOSING DAY. (i.e. Snow)**
5. Aftercare pick up will be in Marian Hall (the church basement). Please park your car in the lot. You may not park along the curb of the church. Enter through side door of the church, down the stairs, and ring the bell.
6. There will be no Aftercare for Preschool when Kindergarten through 8th grade has a half day.
7. There will be no Aftercare the first day of school, Halloween, or the Wednesday before Thanksgiving. Please look at the monthly calendar for additional days that Aftercare will not be available on half days.

Behavior Expectations/Rules for Students:

St. Mary School is committed to creating a successful environment for your children. We believe in respect for each other. Students must be able to understand, follow the program rules, and interact with peers in a socially appropriate manner. The students should keep their hands and feet to themselves and be kind to one another by helping and sharing. The students will not engage in repetitive, aggressive, harmful, or disruptive behavior. If your child is unable to follow the program rules, the following will be instituted:

- 1st infraction – 5-minute time out. Aftercare Director will speak with parent at pickup and the behavior will be noted in log.
- 2nd infraction – 5-minute time out. Aftercare Director will speak with parent at pick up, behavior will be noted in log, and Aftercare Director will speak with the principal.
- 3rd infraction- student will be suspended from the program for 3 days.
- After two suspensions from the program for behavior, the student will be asked to leave the program for the remainder of the school year.

Financial Policies

Payment is due every Monday or the first day of the week your child attends the program. **PAYMENTS MUST BE MADE WEEKLY**. If payments are continuously late, you will be warned, and if it continues, your child will be suspended from the program. Make checks payable to St. Mary School Aftercare, place in an envelope and complete the attached form each week.

The Aftercare Program will be in session every day until **5:30 pm**, with the exception of half days. **Pick up on half days will be at 3:30 pm**. Your child/ren must be picked up on or before **5:30 pm** on full days and **3:30 pm** on half days in Marian Hall. This is the responsibility of the parents. If you are unable to pick up your child/ren by **5:30 pm**, please make other arrangements for your child/ren to be picked up. If parents do not pick up by **5:30 pm** on full days and **3:30 pm** on half days, your emergency contacts will be called to come pick up your child/ren. There will be a late charge of **\$10.00 for the first 5 minutes late with an additional \$1.00 for each minute thereafter** for any child picked up after **5:30 pm** on full days and **3:30 pm** on half days. Continuous **late pick up (2 or more times)** will result in suspension from the program for one week. **If you are suspended from the program 2 times you will be asked to leave the program for the year**. The Aftercare Program is not a baby-sitting convenience for students serving detention or missing their bus. Students will not be permitted to attend the Aftercare Program unless they have been enrolled into the program by a parent or guardian. If you have any questions, please feel free to call the school.

- I understand that payments are due every Monday or the first day of the week that my child/ren attend aftercare.
- I will send payments in an envelope and use the attached sheet with family name, homeroom, week attending, circle the days, and payment amount.
- I understand that aftercare is intended for working parents only and is not for babysitting, play dates, and for students who want to play with their friends.
- I understand that I will need to arrange for my child/ren to be picked up each day by 5:30 pm on full days and 3:30 pm on half days in Marian Hall.
- I understand that if I pick up my child/ren after 5:30 pm on full days and 3:30 pm on half days, I will be charged \$10.00 for the first 5 minutes late and an additional \$1.00 for each minute thereafter.
- I understand that if I am late 2 or more times for pickup, my child/ren will be suspended from the program for one week.
- I understand that if my child/ren does not follow the program rules and acts in an inappropriate manner there will be consequences.
- I understand that if my child/ren is suspended for lateness or behavior two times, they will be asked to leave the program for the year.
